E 121 **Apologies**

E 122 **Public Participation**

Frances Lee, Secretary, Kaiwharawhara Reclamation Working Group

Frances Lee referred to Agenda Item 10, Council-Owned Company and Environmental Sensitivity. Frances Lee said her group supported the thrust of the paper and specifically noted a number of points from that report.

Frances Lee said that against the background of CentrePort's appeal to the Environment Court concerning buildings up to 27 metres on Kaiwharawhara Point and the imminent completion of the Northern Gateway Project requested that the appeal be suspended or alternatively that CentrePort withdraw its appeal.

A copy of Frances Lee's statement was distributed to members with the request that the submission be taken into account when considering Agenda Item 10 in today's order paper.

Frances Lee noted that the Environment Committee's Order Paper had a reference to the Regional Policy Statement Implementation Report and included a paragraph about the Kaiwharawhara Stream. Frances Lee said she was a member of the Trelissick Park Group who wished to co-operate fully in the work on water quality and habitat issues in the lower part of the Kaiwharawhara Stream concluding that it was a most worthwhile project and Frances Lee thanked the Regional Council for their interest.

E 124 **Presentation – South Coast Marine Reserve**

Andrew Cutler, South Coast Marine Reserve Coalition gave a presentation about a proposal for a marine reserve in the Island Bay area. Mr Cutler was assisted by Dr Jonathon Gardener, Victoria University of Wellington who is a technical advisor to the Coalition.

Mr Cutler said the Coalition had approached a number of agencies including the Wellington Regional Council for feedback on technical aspects of their proposal. The Coalition expected to submit a public document within two months when the Wellington Regional Council would have an opportunity to make submissions on the proposal. Following the public process the Ministry of Conservation would then consider, within an undefined time period, whether or not the proposal should be approved as a marine reserve on the south coast.

Members would give further consideration to marine reserves later in the meeting.
