 - b the application of a ten percent discount / rebate for telemetered takes.

- 2 Recommends that Council agrees to adopt, without change, the preferred options in the consultation document for inclusion in the finalised 2021-31 Long Term Plan:
 - a Electric all the way
 - b Sow the seeds now
 - c Serious support

- 3 Recommends that Council agrees to adopt the 2021-31 Long Term Plan, subject to the following changes being included in the finalised 2021-31 Long Term Plan:
 - Additional funding of \$250,000 per annum from 2023/24 until 2027/28 for Predator Free Wellington, subject to additional conditions regarding assisting and sharing best practice learnings across regional Predator Free groups.
 - Additional funding of \$100,000 for 2021/22, increasing to \$300,000 per annum from 2022/23 for the Mauri Tuhono ki Te Upoko o Te Ika (Regional Biodiversity Framework).
 - c That the Long Term Plan signal a commitment to fund Wellington Regional Stadium Trust for earthquake resilience works, totalling \$2.33 million in 2023/24 as a one-third contribution, subject to confirmation of Wellington City Council support.
 - d Funding of \$150,000 per annum from 2021/22 to 2023/24 for additional Greater Wellington park ranger capacity.
 - e That the Long Term Plan signal continued support for the feasibility work on the Wainuiomata Fenced Sanctuary, subject to the Department of Conservation being lead agency.
 - f Additional funding of \$400,000 per annum from 2021/22 onwards, for the whaitua implementation programmes.
 - g Funding the commitment to the living wage for bus drivers (as per 8 April 2021 Council Report 21.92) through reserves for 2021/22.
- 4 That officers report to the Council meeting on 10 June 2022 on whether funding the living wage for bus drivers in 2022/23 and following years can be included in the 2021-31 Long Term Plan or should be the subject of a separate consultation process.

- Solving access issues at the Hiwinui block.
- Analysis of the Otaki River to Rail 'Regional Park' opportunity.
- Report back on paper road access through Belmont Regional Park Hill to Belmont Roads.

Noted: The Committee requested that officers prepare reports to the Transport Committee on:

- The feasibility of using renewable bio-fuel for buses as an interim measure prior to electrification.
- The fare structure review giving consideration to concessions for part time students.

Noted: The Committee proposed that a letter be sent from the Council Chair to the Minister of Transport regarding compatibility between future Light Rail and heavy rail networks.

Noted: The Revenue and Finance Policy will be formally reviewed, including a public consultation, in the 2021/22 financial year.
